#### Composition

Disugar Tablet: Each tablet contains Rebaudioside A 30 mg which is extract of Stevia

## Description

Disugar (Rebaudioside A) is 100% natural, which contains zero calories sweetener and has no known adverse health effects. It is completely safe, high-intensity sweetener that is about 350 to 450 times sweeter than sugar. Disugar (Rebaudioside A) is considered the best ingredients among all steviol glycosides of stevia. It has no additives and no preservatives. It has been shown to lower blood sugar and blood pressure levels.

Disugar (Rebaudioside A) is approved GRAS status in 2008 by the USFDA for its use as a sweetener in a variety of food products and as a tabletop sweetener. Its safety has also been approved by the EFSA, JECFA & FSANZ. So, Disugar (Rebaudioside A) is safer than artificial sugar and tabletop sugar.
