Description

Composition

Each 5 ml syrup contains Vit. A (as retinol palmitate) USP 425 IU, Vit. A (as beta carotene) USP 425 IU, Vit. B1 (Thiamine hydrochloride) BP 1mg, Vit. B2 (Riboflavin as 5-phosphate sodium) BP 1 mg, Vit. B3 (Niacinamide) USP 5 mg, Vit. B5 (Pantothenic acid) USP 3.5 mg, Vit. B6 (Pyridoxine hydrochloride) BP 1 mg, Vit. B12 (Cyanocobalamin) BP 3 mcg, Vit. C (Ascorbic acid) BP 67.5 mg, Vit. D3 (Cholecalciferol) BP 137.5 IU, Vit. E (as d-alpha-tocopherol acetate) BP 10 IU, Biotin BP 32.5 mcg, Inositol BP 10 mg, Folic acid BP 67.5 mcg, Para-aminobenzoic acid (PABA) USP 0.5 mg, Calcium (as lactate) BP 27.5 mg, Chromium (as polynicotinate) pharma grade 3.5 mcg, Iodine USP 25 mcg, Magnesium (as lactate) pharma grade 7.5 mg, Potassium (as citrate) USP 7 mg, Selenium (as selenomethionine) USP 17.5 mcg, Choline bitartrate USP 10 mg, Manganese (as gluconate) USP 0.75 mg and Zinc (as gluconate) USP 2.5 mg.

Indication

Nutrum Junior is indicated to meet the increased demands of vitamins and minerals for growing children. This combination is also indicated for the prevention and treatment of vitamin and mineral deficiencies and lack of appetite of children.

Dosage and Administration

Infants up to 1 year: 1 teaspoon daily

Children 1 to 4 years: 1-2 teaspoons daily

Children 4 to 12 years: 2-3 teaspoons daily

Side Effects

Vitamin and mineral supplements are usually well tolerated. No side effect is reported at recommended dose with this combination. Vitamin C & Vitamin E in large doses may cause diarrhea & other gastrointestinal disturbances.

Contraindication

This product is contraindicated to them who are hypersensitive to any of the ingredients of this product.

Drug Interaction

No prominent drug interaction has been reported.

Supply

Each PET bottle contains 100 ml syrup with a measuring spoon.

Keep all medicines out of reach of children.

Store in a cool and dry place protected from light.
